1. BYTOWN MUSEUM CELEBRATES A 100 YEARS OF SERVICE TO OTTAWA – PRESENTATION

Robin Etherington, Executive Director of the Bytown Museum gave a verbal presentation regarding the 100th anniversary of the museum. She spoke to a number of items and thanked the City for their ongoing support.

Committee members had some general questions about how they managed to increase their attendance, how they keep their museum up to date and their financial footing. They have an overall budget \$650,000 an operating grant \$315,000 and grants from the province and project grants and they consistently meet the budget each year.

2. ALCOHOL AND GAMING COMMISSION OF ONTARIO - OVERVIEW

Rebecca Castillo, Manager, Liquor Eligibility and Jeff Longhurst, Director, Licensing and Registration with the Alcohol and Gaming Commission of Ontario gave a PowerPoint presentation on Liquor Service – Rules and Practices. Following the presentation Committee members had a variety of questions. Councillor Fleury stated that they have authority that can influence and result in the City incurring costs i.e. extending bus service, police resource cost, etc... How does that work across the province? Rebecca indicated that 99% of the hours they issue are of municipal significance. They require that it has to be a live event. She stated that they don't need a to get a resolution by the city involved, but applicants are required to notify local police and their representatives have good relationship with city staff.

There was also a discussion on extension of hours and costs involved.

Does the AGCO work with local Health Departments and the answer is yes, they are at the table.

6. SANCTUARY CITY INFORMATION REPORT

**CITY WIDE** 

That the Community and Protective Services Committee receive this report for information.

Chair Deans gave a brief introduction stating that this was Councillor McKenney's report and that she would speak to it.

On a point of order Councillor Egli stated that in the report it mentions that a motion is forthcoming. He noted that if there is a motion it should be tabled now. Chair Deans responded saying that she believed there was no motion forthcoming and that this is an information report.

Councillor McKenney stated that the Sanctuary City policies have two important components and that at this meeting and in this city we are trying to understand what a Sanctuary City is. She said that when people access city services they

won't be questioned on their immigration status and when questioned about it they don't have to give out that information. She also stated that there is no motion.

The following are the points raised by the majority of delegations who support the concept of Sanctuary City:

- Alleviate fears of those vulnerable seeking medical assistance, housing, financial help, etc...
- With increase of violence and discrimination re: refugees, assists in feeling safe and included.
- More important for women and children.
- Some studies show that there is little added cost if not lower in those
   Cities who have instituted Sanctuary City status.
- · Moral obligation.
- Allows services to those who are already struggling.
- Important human rights issue.
- Provide training to front line staff on compassion and understanding of those seeking the assistance.
- Helps in forming trust in a new and foreign land and culture.

Following the delegations Committee members voiced their questions and comments.

- There was a lot of good dialogue.
- Is immigration status needed for vaccinations? No. Open to all, no status is asked.
- Legal conflict with Provincial and Federal programs? Would have to be reviewed but for something like Ontario Works, disclosure of immigration status is required.
- Councillor McKenney is not contemplating a vote today or in near future.
- What is Council's authority in terms of directing police and how to conduct themselves? Legal Services stated that Council has no authority to direct the Police Services Board.
- With regards to recreation programs offered by the City, the information collected is very narrow and limited to what is needed to administer a program. Over 50% is collected through self-serve channels and the

information there is limited to what they need for their programs and contains nothing about immigration, citizenship et cetera.

- What would be the expectation from City's partners in Community Services? City has over 400 partners and there is no requirement to gather information on status. There is a requirement from the province for some programs such as child care, Ontario Works et cetera that does require status.
- What are the implications of a don't ask don't tell policy and the legal implications of it? Legal Services noted it was an unknown at the moment until more research is done on the subject.
- In terms of policing, understanding is that they don't proactively check on people's immigration status is that correct? That would be up to police to answer.
- Our city services are being provided to all. People will be treated with respect regardless of immigration status.
- Councillor McKenney in wrap up: It's not whether they are being turned away but it is what would happen if they don't come forward. Have to find a way to alleviate that fear and the easiest way to do that is to tell people that we have a policy at the city that says we will never give away information on their status. Other cities have done this; it's training staff and it's not expensive and it's reporting back. It's worth it.
- Chair Deans in wrap up: Thanked public who came out today. It was an important conversation today. Heard delegations say there is a fear.
   There is a role for the municipality in alleviating that fear. One of the City's most important jobs is to ensure the well being of its citizens.
   Heard that people are afraid to access City services and we have a role to play in working to find a solution so people can be full participants in the city.
