BACKGROUND

At its meeting of 12 September 2012, City Council considered a report titled “Advisory Committee Renewal to Support Council’s Term of Council Priorities” (ACS2012-CMR-CCB-0032) and approved the establishment of a new Advisory Committee structure, including the new Arts, Culture, Heritage and Recreation Advisory Committee.

Beginning 14 September 2012, advertisements appeared in local newspapers and on Ottawa.ca to recruit citizen volunteers to serve on the new Advisory Committees. The deadline for submitting an application was 18 October 2012.

DISCUSSION

The Selection Panel for the citizen members consisted of Councillors Mark Taylor and Shad Qadri as well as Danielle McGee as a representative of Mayor Watson. In December 2012 and January 2013, the Selection Panel met to review applications, short-list candidates and conduct interviews.

The selection process is now completed, and this report presents the recommendations of the Selection Panel to Council for approval.

Given that the new governance structure will be re-examined as part of the end of term governance review, these citizen member appointments are being recommended until the end of this term of Council, with the possibility of renewal subject to the aforementioned governance review.

Pursuant to the report approved by Council on 12 September 2012, all appointees will be required to attend an orientation/training session prior to their first meeting.

Recruitment advertisements were placed in local newspapers and on Ottawa.ca beginning September 12, 2012 and circulated to numerous community groups and organizations. Recruitment flyers were also available at all of the City’s Client Services Centres and at every branch of the Ottawa Public Library. In addition, all members of the former Advisory Committees received formal notification and were invited to apply

through this process.

The application deadline was 18 October 2012.
