**PURPOSE OF THE APPLICATIONS:**

The Owner wants to demolish the existing dwelling, detached garage, shed and in-ground pool and subdivide his property into six separate parcels of land. It is proposed to convey two separate portions of his property to the abutting landowner to the north to form part of two new residential lots which will each contain a proposed two-storey detached dwelling. The remaining four parcels will each contain a proposed two-storey detached dwelling.
