The subject matter of this report centres around consideration of collective bargaining mandates for Amalgamated Transit Union (ATU) Local 279

(Para Transpo) and ATU Local 1760 (Administrative Supervisors). More specifically, it relates to establishing mandates for, and directing staff in relation to, bargaining for the renewal of a collective agreement for ATU 279 and negotiating the first collective agreement for ATU 1760.

In accordance with the provisions of Subsection 239(2)(d) of the *Municipal Act,* 2001, as well as Subsection 13(6) of the *Procedure By-law*, the subject matter of this report deals with "labour relations and employee negotiations." Therefore, the report may be received and considered by Transit Commission and City Council, and direction given to staff, in closed session.
