PURPOSE OF THE APPLICATION:

The Owner wants to convey portions of its property to the abutting landowners to the north and west of the subject property.

CONSENT IS REQUIRED FOR THE FOLLOWING:

In order to do this, the Owner requires the Consent of the Committee for Conveyances and a Joint Use and Maintenance Agreement.

B-00085: Lot Line Adjustment

The lands to be conveyed are shown as Part 1 on Plan 4R-32773, filed with the application and will contain a lot area of 22.7 square metres. This landlocked parcel is to be merged with the property to the north shown as Block 237 on 4M-1617.

B-00086 Lot Line Adjustment

The lands to be conveyed are shown as Part 2 on Plan 4R-32773, filed with the application and will contain a lot area of 49.9 square metres. This landlocked parcel is to be merged with the property to the north shown as Block 238 on 4M-1617.

B-00087: Grant of Easement/Right-of-Way

The lands subject the to Grant of Easement/Right-of-Way are shown as Part 3 on Plan 4R-32773, filed with the application and will contain a lot area of 327.4 square metres. This parcel will be used as a servicing easement (storm, sanitary, drainage) in favour of Block 203 on Draft 4M Plan, filed with the application.

The remnant parcel will have frontage of 121 metres on Bank Street and 70.39 metres on Don Skipper Drive and will contain a lot area of 2.4 hectares. This parcel contains the existing Home Hardware building, which is to be demolished as part of an overall commercial development of the site.

THE APPLICATION indicates that the Property is the subject of a Site Plan Application (D07-12-19-0092) under the *Planning Act*.

YOU ARE ENTITLED TO PARTICIPATE in the Committee of Adjustment Public Hearing concerning these applications because you are an assessed owner of one of the neighbouring properties. See Annex A – Public Participation Details on providing written submissions or verbal comments in advance of the hearing, and how to register to speak at the hearing. The Committee asks that any presentations be limited to five minutes or less, and any exceptions will be at the discretion of the Committee Chair. You may require the Committee to hold the hearing as an oral (in person) hearing if you satisfy the Committee that holding the hearing as an electronic hearing is likely to cause you significant prejudice. To do so, you must provide written submissions to the Committee at least 48 hours in advance of the hearing.

IF YOU DO NOT PARTICIPATE in this Public Hearing, it may proceed in your absence and, except as otherwise provided in the *Planning Act*, you will not be entitled to any further notice in the proceedings. If you have specific comments regarding these applications, you may submit a letter to the Secretary-Treasurer of the Committee at the address shown below, and such written submissions shall be available for inspection by

any interested person. Information you choose to disclose in your correspondence, including your personal information, will be used to receive your views on the relevant issues to enable the Committee to make its decision on this matter. The information provided will become part of the public record. Every attempt should be made to file your submission five days prior to the Public Hearing date.

IF YOU WISH TO BE NOTIFIED of the Decision of the Committee of Adjustment in respect of the proposed consent, you must make a written request to the Secretary-Treasurer of the Committee of Adjustment at the address shown below. This will also entitle you to be advised of a possible Local Planning Appeal Tribunal Hearing. Even if you are the successful party, you should request a copy of the Decision since the Committee of Adjustment's Decision may be appealed to the Local Planning Appeal Tribunal by the Applicant or another member of the public.

IF A PERSON OR PUBLIC BODY THAT FILES AN APPEAL against a decision of the Committee of Adjustment in respect of the proposed consent has not made a written submission to the Committee of Adjustment before it gives or refuses to give consent, the Local Planning Appeal Tribunal may dismiss the appeal.
