**PURPOSE OF THE APPLICATION:**

The Owner wants to demolish the existing dwelling and construct a three storey, 11-unit residential apartment building, with a communal landscaped rear yard, as shown on plans filed with the Committee.

**RELIEF REQUIRED:**

In order to proceed, the Owner requires the Authority of the Committee for Minor Variances from the Zoning By-law as follows:

- a) To permit a reduced front yard setback of 4.5 metres, whereas the By-law requires a minimum front yard setback of 5.98 metres (equal to the front yard setback of the abutting lot).
- b) To permit a reduced corner side yard setback of 3.5 metres (along Currell Avenue), whereas the By-law requires a minimum corner side yard setback of 4.5 metres.
- c) To permit a reduced communal amenity area of 82% of total amenity area for the first eight units or 99.35 square metres, whereas the By-law states that 100% of the required amenity area for the first eight units must be communal, and in this case would be equal to 120 square metres.
- d) To permit the requirement for an additional yard abutting the interior and rear lot line of the property, with dimensions of 8.5 metres by 4.6 metres, to not apply to this property.
- e) To permit an increased building height of 11.35 metres, whereas the By-law permits a maximum height of 11 metres.

It should be noted that for By-law purposes, Churchill Avenue North is deemed to be the front yard for this property.

**THE APPLICATION** indicates that the Property is the subject of a Site Plan Control Application (File No. D07-12-19-0118) under the *Planning Act*.

**YOU ARE ENTITLED TO PARTICIPATE** in the Committee of Adjustment Public Hearing concerning this application because you are an assessed owner of one of the neighbouring properties. See *Annex A – Public Participation Details* below on providing written submissions or verbal comments in advance of the hearing, and how to register to speak at the hearing. The Committee asks that any presentations be limited to five minutes or less, and any exceptions will be at the discretion of the Committee Chair. You may require the Committee to hold the hearing as an oral (in person) hearing if you satisfy the Committee that holding the hearing as an electronic hearing is likely to cause you significant prejudice. To do so, you must provide written submissions to the Committee at least 48 hours in advance of the hearing.

**IF YOU DO NOT PARTICIPATE** in this Public Hearing, it may proceed in your absence and, except as otherwise provided in the *Planning Act*, you will not be entitled to any further notice in the proceedings. If you have specific comments regarding this application, you may submit a letter to the Secretary-Treasurer of the Committee at the address shown below, and such written submissions shall be available for inspection by any interested person. Information you choose to disclose in your correspondence, including your personal information, will be used to receive your views on the relevant issues to enable the Committee to make its decision on this matter. The information

provided will become part of the public record. Every attempt should be made to file your submission five days prior to the Public Hearing date.

**A COPY OF THE DECISION** of the Committee will be sent to the applicant/agent, and to each person who appeared in person or who was represented at the Public Hearing AND who filed with the Secretary Treasurer a written request to receive the decision. This will also entitle you to be advised of a possible Local Planning Appeal Tribunal Hearing. Even if you are the successful party, you should request a copy of the Decision since the Committee of Adjustment's Decision may be appealed to the Local Planning Appeal Tribunal by the Applicant or another member of the public.
