**PURPOSE OF THE APPLICATIONS:**

At its January 8, 2020 Hearing the Committee adjourned these applications in order to allow the Owner time to further investigate servicing requirements for each of the proposed lots. The Owner wants to subdivide its property into four vacant parcels of land for future development of single-detached dwellings, one on each of the vacant lots.

**CONSENT IS REQUIRED FOR THE FOLLOWING:**

In order to do this, the Owner requires the Consent of the Committee for Conveyances, Partial Discharge of mortgage/charge and Mortgage/charge.

The property is shown as Parts 1-8 on sketches filed with the applications and the separate parcels are as follows:

The land to be retained, shown as Parts 6, 7 and 8 on a sketch filed with the applications, will have frontages of 38.70 metres on Prince of Wales and 194.75 metres on Rideau Glen Drive and will contain a lot area of 7,090 7341square metres. This parcel is vacant and will be known municipally as 2927 Prince of Wales Drive.

It should be noted that, for By-law purposes, the frontage on Prince of Wales Drive is deemed to be the front lot line for this property.

The Owner indicates that Minor Variance Applications (D08-02-19/A-00315 to D08-02-19/A-00318), relating to the reduction to the watercourse setback and previously to be heard concurrently with the original consent applications, are no longer necessary under the revised proposal. These Minor Variance Applications will remain adjourned *sine die* and would be withdrawn following an approval of these amended consent applications.

**YOU ARE ENTITLED TO PARTICIPATE** in the Committee of Adjustment Public Hearing concerning these applications because you are an assessed owner of one of the neighbouring properties. See Annex A – Public Participation Details on providing written submissions or verbal comments in advance of the hearing, and how to register to speak at the hearing. The Committee asks that any presentations be limited to five minutes or less, and any exceptions will be at the discretion of the Committee Chair. You may require the Committee to hold the hearing as an oral (in person) hearing if you satisfy the Committee that holding the hearing as an electronic hearing is likely to cause

you significant prejudice. To do so, you must provide written submissions to the Committee at least 48 hours in advance of the hearing.

**IF YOU DO NOT PARTICIPATE** in this Public Hearing, it may proceed in your absence and, except as otherwise provided in the *Planning Act*, you will not be entitled to any further notice in the proceedings. If you have specific comments regarding these applications, you may submit a letter to the Secretary-Treasurer of the Committee at the address shown below, and such written submissions shall be available for inspection by any interested person. Information you choose to disclose in your correspondence, including your personal information, will be used to receive your views on the relevant issues to enable the Committee to make its decision on this matter. The information provided will become part of the public record. Every attempt should be made to file your submission five days prior to the Public Hearing date.

**IF YOU WISH TO BE NOTIFIED** of the Decision of the Committee of Adjustment in respect of the proposed consent, you must make a written request to the Secretary-Treasurer of the Committee of Adjustment at the address shown below. This will also entitle you to be advised of a possible Local Planning Appeal Tribunal Hearing. Even if you are the successful party, you should request a copy of the Decision since the Committee of Adjustment's Decision may be appealed to the Local Planning Appeal Tribunal by the Applicant or another member of the public.

**IF A PERSON OR PUBLIC BODY THAT FILES AN APPEAL** against a decision of the Committee of Adjustment in respect of the proposed consent has not made a written submission to the Committee of Adjustment before it gives or refuses to give consent, the Local Planning Appeal Tribunal may dismiss the appeal.
