That the Ottawa Police Services Board approve payment of \$7,500.00 (HST exempt) to the Canadian Association of Police Governance for its 2021 membership fee.

BACKGROUND

Attached as Document 1 is the 2021 membership renewal information for the Canadian Association of Police Governance (CAPG).

The Ottawa Police Services Board has been a member of the CAPG since 1995 and has been an active supporter in past years. In addition to providing staffing support to the Association for nine years from 1997 through 2005, former Board Chair Herb Kreling served for seven years on the Board of Directors, including two terms as President from

August 2001 to August 2003. In 2016, Member Smallwood served on the CAPG Board as Secretary and is currently Vice President.

The CAPG will be holding its 2021 Annual General Meeting virtually within their legislated time frame (by September 30, 2021) and the conference in October 2021. This remains dependant on the ongoing Covid-19 pandemic. Ottawa is the host board for the 2021 annual conference.

FINANCIAL IMPLICATIONS

The 2021 annual membership fee for police services boards with over 1,000 employees has increased since 2019 to \$7,500.00 (tax exempt) from \$6,094.00. Funds to cover this expense were included in the Board's 2021 budget.
