**PURPOSE OF THE APPLICATION:**

The Owner wants to construct a two-storey addition at the rear of their existing rooming house, with a patio space above, as shown on plans filed with the Committee. The application indicates that the addition will contain three new rooming units along with interior and exterior amenity space.

**RELIEF REQUIRED:**

In order to proceed, the Owner requires the Authority of the Committee for Minor Variances from the Zoning By-law as follows:

- a) To permit a reduced total amenity space of 48.5 square metres, to be comprised of 6 square metres in the rear yard, 21.6 square metres in a 2<sup>nd</sup> floor lounge and 20.9 square metres on the proposed patio, whereas the By-law requires 108 square metres of communal amenity area (7 square metres for the first 8 units and 3 square metres for each unit in excess of 8), which must be located at grade and in the rear yard or interior side yard, be landscaped and consist of at least 80% soft landscaping.
- b) To permit a corner side yard setback of 1.87 metres for the garbage and recycling enclosure, which will form part of the addition, whereas the By-law requires a minimum corner side yard setback of 3.0 metres.

**THE APPLICATION** indicates that the Property is the subject of a current Site Plan Control Application (D07-12-20-0143) under the *Planning Act*.

**YOU ARE ENTITLED TO PARTICIPATE** in the Committee of Adjustment Public Hearing concerning this application because you are an assessed owner of one of the neighbouring properties. See *Annex A – Public Participation Details* below on providing written submissions or verbal comments in advance of the hearing, and how to register to speak at the hearing. The Committee asks that any presentations be limited to five minutes or less, and any exceptions will be at the discretion of the Committee Chair. You may require the Committee to hold the hearing as an oral (in person) hearing if you satisfy the Committee that holding the hearing as an electronic hearing is likely to cause you significant prejudice. To do so, you must provide written submissions to the Committee at least 48 hours in advance of the hearing.

**IF YOU DO NOT PARTICIPATE** in this Public Hearing, it may proceed in your absence and, except as otherwise provided in the *Planning Act*, you will not be entitled to any further notice in the proceedings. If you have specific comments regarding this application, you may submit a letter to the Secretary-Treasurer of the Committee at the address shown below, and such written submissions shall be available for inspection by any interested person. Information you choose to disclose in your correspondence, including your personal information, will be used to receive your views on the relevant issues to enable the Committee to make its decision on this matter. The information provided will become part of the public record. Every attempt should be made to file your submission five days prior to the Public Hearing date.

**A COPY OF THE DECISION** of the Committee will be sent to the applicant/agent, and to each person who appeared in person or who was represented at the Public Hearing AND who filed with the Secretary Treasurer a written request to receive the decision. This will also entitle you to be advised of a possible Local Planning Appeal Tribunal Hearing. Even if you are the successful party, you should request a copy of the

Decision since the Committee of Adjustment's Decision may be appealed to the Local Planning Appeal Tribunal by the Applicant or another member of the public.
